DISCUSSION:

BPS Maintenance uses the Florida State Term Contract 25101900-21-STC to purchase grounds and lawn mowing equipment.

As allowed per Florida Administrative Code 6A-1.012(5) and required by Section 1001.42(10)(j), F.S., the district school board shall receive and give consideration to the prices available to it under rules of the Department of Management Services, Division of Purchasing. District school boards may use prices established by the Division of Purchasing through the state purchasing agreement price schedule. If district school board policy provides for purchasing under this program of state purchasing agreements the conditions for use shall be those imposed on state agencies.

The standard state contract agenda template has been used, which does not require legal review.

CONTRACT TERM:

The initial contract term shall commence March 10, 2021 and continue until December 31, 2023.

RECOMMENDATION:

It is the recommendation of Susan Hann, Assistant Superintendent of Facilities Services and James Ross, Director of Plant Operations & Maintenance to approve the utilization of the State contract with the vendors listed in Exhibit A in the amount of \$400,000.00.
