PRICE INCREASE / DECREASE EXPLANATION: Due to the increased need for testing services, the contract value is anticipated to exceed \$50,000.

DISCUSSION:

On August 24, 2021, the Superintendent approved an agreement with COTG2021 LLC for COVID Testing Services with a contract value less than \$50,000. The agreement provides for COVID-19 Rapid Antigen Testing Services at locations designated by BPS, on an as-needed basis. Requesting Board approval of Amendment 1 to increase the contract value to variable.

The standard amendment template has been used, which does not require legal review.

CONTRACT TERM:

The contract term commenced August 24, 2021 and shall continue until December 31, 2021.

RECOMMENDATION:

It is the recommendation of Beth Thedy, Ed.D., Deputy Superintendent/Chief Human Resources Officer and Antonia Scipio, Director of Employee Benefits and Risk Management to approve the attached amendment with COTG2021 LLC in the amount of variable.

THIS AMENDMENT (hereinafter referred to as "Amendment") to the agreement identified above (referred to as the "Agreement") by and between The School Board of Brevard County, Florida, a political subdivision of the State of Florida, located at 2700 Judge Fran Jamieson Way, Viera, Florida 32940, more commonly known as Brevard Public Schools (hereinafter referred to as "BPS") and COTG2021 LLC whose business address is 1220 PROSPECT AVE, STE 294, MELBOURNE, FL 32901, (hereinafter referred to as "Contractor"), is made as follows:

WITNESSETH:

WHEREAS, pursuant to the terms of the Agreement, the parties may amend the Agreement upon mutual written consent; and

WHEREAS, BPS and Contractor wish to amend the Agreement to modify the contract value through this Amendment;

NOW, THEREFORE, in consideration of the mutual covenants and provisions contained herein, the parties hereto agree as follows:

1. Increase the value of the contract from \$49,999.99 to variable.
 2. The above recitals are true and correct and are hereby incorporated by reference.
 3. Except as expressly modified herein, the terms and conditions of the Agreement remain unchanged.
- In the event of a conflict between the terms of this Amendment and those of the Agreement, BPS and Contractor agree that the terms of this Amendment shall prevail and control.
