**PRICE INCREASE / DECREASE EXPLANATION:** The hourly wage minimum pay for state workers has increased.

**DISCUSSION:**

Governor DeSantis approved an increase of wage minimum pay to Health Support Technicians (HST) effective July 1, 2021. The increase for HST will increase from \$12.00 per hour plus 1.45% FICA tax to \$13.00 per hour plus 1.45% FIC tax.

The standard amendment template has been used, which does not require legal review.

**CONTRACT TERM:**

The initial contract term shall remain the same; July 1, 2019 and continue until June 30, 2022.

**RECOMMENDATION:**

It is the recommendation of Christine Moore, Assistant Superintendent of Student Services and Dr. Jayna Jenkins, Director of Student Support Services to approve the attached amendment with the Florida Department of Health, Brevard County in the amount of an additional \$110,372.00.

**THIS AMENDMENT** (hereinafter referred to as “Amendment”) to the agreement identified above (referred to as the “Agreement”) by and between The School Board of Brevard County, Florida, a political subdivision of the State of Florida, located at 2700 Judge Fran Jamieson Way, Viera, Florida 32940, more commonly known as Brevard Public Schools (hereinafter referred to as “BPS”) and Florida Department of Health, Brevard County whose business address is 2575 North Courtenay Parkway, Merritt Island, Florida 32953, (hereinafter referred to as “Contractor”), is made as follows:

**WITNESSETH:**

**WHEREAS**, pursuant to the terms of the Agreement, the parties may amend the Agreement upon mutual written consent; and

**WHEREAS**, BPS and Contractor wish to amend the Agreement to increase the minimum pay the Health Support Technicians (HST) through this Amendment;

**NOW, THEREFORE**, in consideration of the mutual covenants and provisions contained herein, the parties hereto agree as follows:

1. Governor DeSantis increased the minimum pay for all state workers to \$13.00/hour effective July 1<sup>st</sup>. This will have an impact for Health Support Technicians (HST) that currently are at \$12.00/hour. See Attachment 1.
2. The above recitals are true and correct and are hereby incorporated by reference.
3. Except as expressly modified herein, the terms and conditions of the Agreement remain unchanged. In the event of a conflict between the terms of this Amendment and those of the Agreement, BPS and Contractor agree that the terms of this Amendment shall prevail and control.

### Amendment of Hourly Wage Minimum to \$13.00

The hourly rates of the school-based OPS School Health staff will be as follows:

Health Support Technicians (HST) - \$ 13.00 per hour plus 1.45% FICA tax

Licensed Practical Nurses (LPN) - \$ 17.00 per hour plus 1.45% FICA tax

Registered Nurses (RN) - \$ 23.00 per hour plus 1.45% FICA tax

Staffing levels in each school will be based on collaboration of DISTRICT and PROVIDER based on medical needs of the students.

Other Positions - Information based on January 2019 Salaries and Benefits. May be subjected to State Legislature Cost of Living pay increases in Salaries and Benefits for all State employees.
