**PRICE INCREASE / DECREASE EXPLANATION:** The initial contract started the process of getting the essential health services in place for the student’s health needs. The requested amount is estimated to cover the needed positions throughout the school year.

**DISCUSSION** The purpose of the agreement was to secure a qualified agency to provide an LPN or RN for a student with a disability requiring medical assistance on a continued basis throughout the school day.

The standard amendment template has been used, which does not require legal review.

**CONTRACT TERM:**

The initial contract term commenced August 17, 2022 and shall continue through May 31, 2023.

**Amendment “I”  
To Agreement Between

**THIS AMENDMENT** (hereinafter referred to as “Amendment”) to the agreement identified above (referred to as the “Agreement”) by and between The School Board of Brevard County, Florida, a political subdivision of the State of Florida, located at 2700 Judge Fran Jamieson Way, Viera, Florida 32940, more commonly known as Brevard Public Schools (hereinafter referred to as “BPS”) and Pediatric Services of America, LLC. dba Aveanna Healthcare whose business address is 760 North Drive, Suites C-F, Melbourne, FL 32934, (hereinafter referred to as “Contractor”), is made as follows:

**WITNESSETH:**

**WHEREAS**, pursuant to the terms of the Agreement, the parties may amend the Agreement upon mutual written consent; and

**WHEREAS**, BPS and Contractor wish to amend the Agreement to modify the fee and term date through this Amendment;

**NOW, THEREFORE**, in consideration of the mutual covenants and provisions contained herein, the parties hereto agree as follows:

1. Increase the agreement to one hundred thousand dollars and zero cents (\$100,000.00).
2. Modify the term date to end May 31, 2023.
3. The above recitals are true and correct and are hereby incorporated by reference.
4. Except as expressly modified herein, the terms and conditions of the Agreement remain unchanged. In the event of a conflict between the terms of this Amendment and those of the Agreement, BPS and Contractor agree that the terms of this Amendment shall prevail and control.
