PRICE INCREASE / DECREASE EXPLANATION: Currently, the agreement maximum is written for \$24,900.00. This needs to be increased by \$50,100.00 for a total contract amount of \$75,000.00. This increase is to allow them to continue to serve the schools they already have in place and to add more schools and children. Also, to ensure we don't need to make another amendment before May 2024.

DISCUSSION:

This contract is for one of BAS's self-supported enrichment programs. The parents pay for services, and BAS pays the vendor 82% of the total collected, resulting in 18% in BAS revenue.

CONTRACT TERM:

The initial contract term commenced on August 29, 2023, and continues until June 30, 2024.

THIS AMENDMENT (hereinafter referred to as “Amendment”) to the agreement identified above (referred to as the “Agreement”) by and between The School Board of Brevard County, Florida, a political subdivision of the State of Florida, located at 2700 Judge Fran Jamieson Way, Viera, Florida 32940, more commonly known as Brevard Public Schools (hereinafter referred to as “BPS”) and Aspire Athletics LLC whose business address is 675 North Hunt Club Blvd., Longwood, FL 32779, (hereinafter referred to as “Contractor”), is made as follows:

WITNESSETH:

WHEREAS, pursuant to the terms of the Agreement, the parties may amend the Agreement upon mutual written consent; and

WHEREAS, BPS and Contractor wish to amend the Agreement to modify the maximum amount spent through this Amendment;

NOW, THEREFORE, in consideration of the mutual covenants and provisions contained herein, the parties hereto agree as follows:

1. Currently, the agreement maximum is written for \$24,900.00. This needs to be increased by \$50,100.00 for a total contract amount of \$75,000.00. This increase is to allow them to continue to serve the schools they already have in place and to add more schools and children. Also, to ensure we don't need to make another amendment before May 2024.
2. This contract is for one of BAS's self-supported enrichment programs. The parents pay for services, and BAS pays the vendor 82% of the total collected, resulting in 18% in BAS revenue.
3. The above recitals are true and correct and are hereby incorporated by reference.
4. Except as expressly modified herein, the terms and conditions of the Agreement remain unchanged. In the event of a conflict between the terms of this Amendment and those of the Agreement, BPS and Contractor agree that the terms of this Amendment shall prevail and control.
