District school boards may use prices established by the Division of Purchasing through the state purchasing agreement price schedule. If district school board policy provides for purchasing under this program of state purchasing agreements the conditions for use shall be those imposed on state agencies.

Pricing has been established by the State of Florida Department of Management Services Contract # 25100000-23-STC.

CONTRACT TERM:

The initial contract term shall commence on July 12, 2023, and continue until May 16, 2025, with an optional renewal following the Florida State Contract #25100000-23-STC.
