PRICE INCREASE / DECREASE EXPLANATION: The attached amendment adds an additional anchor site, Apollo Elementary. The new anchor site will increase the fees to an additional \$4,050.00.

DISCUSSION:

The requirement for requesting competitive solicitations for commodities or contractual services from three or more sources is hereby waived as authorized by Section 1010.04(4)(a), F.S., for the purchase by district school boards of educational services and any type of copyrighted materials, where such materials are purchased directly from the producer or publisher, the owner of the copyright, an exclusive agent within the state, a governmental agency, or a recognized educational institution.

Conscious Discipline provides a comprehensive, trauma-informed social-emotional program that is based on current brain research, child development information and developmentally appropriate practices. All aspects of Conscious Discipline focus on creating a safe, connected environment for children to learn and practice the skills needed for healthy social, emotional, and academic development. Funding is for ongoing training, face-to-face coaching, and virtual check-ins throughout the year.

The standard Amendment template has been used, which does not require legal review.

CONTRACT TERM:

The initial contract term commenced August 1, 2022 and continue until May 30, 2023 with two (2) additional one (1) year renewal options.

RECOMMENDATION:

It is the recommendation of Christine Moore, Assistant Superintendent of Student Services and Chris Reed, Director of Student Services to approve the attached amendment with Loving Guidance, Inc. for Conscious Discipline Training and Coaching.

THIS AMENDMENT (hereinafter referred to as "Amendment") to the agreement identified above (referred to as the "Agreement") by and between The School Board of Brevard County, Florida, a political subdivision of the State of Florida, located at 2700 Judge Fran Jamieson Way, Viera, Florida 32940, more commonly known as Brevard Public Schools (hereinafter referred to as "BPS") and **Loving Guidance, Inc Db a Conscious Discipline** whose business address is 820 W. Broadway, Oviedo FL 32765, (hereinafter referred to as "Contractor"), is made as follows:

WITNESSETH:

WHEREAS, pursuant to the terms of the Agreement, the parties may amend the Agreement upon mutual written consent; and

WHEREAS, BPS and Contractor wish to amend the Agreement to modify adding an additional anchor site which increased the agreement price by \$4,050.00 this Amendment;

NOW, THEREFORE, in consideration of the mutual covenants and provisions contained herein, the parties hereto agree as follows:

1. An additional school will need to be included. The new school is Apollo Elementary. They will receive the same services as the 6 new anchor sites (now 7).

 - (10) 1-hour virtual coaching/consultation sessions, with teachers (monthly) 10 \$225.00 **\$2,250.00**
 - (4) 1-hour virtual coaching/consultation sessions, with Administration (quarterly) 4 \$225.00 **\$900.00**
 - (4) 1-hour virtual coaching/consultation sessions, with CDAT (quarterly) 4 \$225.00 **\$900.00**
 - Subtotal \$4,050.00
 - Taxes \$0.00
 - **TOTAL \$4,050.00**

2. The above recitals are true and correct and are hereby incorporated by reference.

3. Except as expressly modified herein, the terms and conditions of the Agreement remain unchanged. In the event of a conflict between the terms of this Amendment and those of the Agreement, BPS and Contractor agree that the terms of this Amendment shall prevail and control.
