PRICE INCREASE / DECREASE EXPLANATION: It is necessary to increase the value of this contract to variable to accommodate the ESSER, capital and surtax flooring projects.

DISCUSSION:

At the March 10, 2020 Board meeting, the Board approved the above State of Florida Flooring Materials, with Related Supplies and Services contract.

As allowed per Florida Administrative Code 6A-1.012(5) and required by Section 1001.42(10)(j), F.S., the district school board shall receive and give consideration to the prices available to it under rules of the Department of Management Services, Division of Purchasing. District school boards may use prices established by the Division of Purchasing through the state purchasing agreement price schedule. If district school board policy provides for purchasing under this program of state purchasing agreements the conditions for use shall be those imposed on state agencies. Pricing has been established by the State of Florida Department of Management Services Contract # 30161700-20-ACS.

The standard state contract agenda template has been used, which does not require legal review.

CONTRACT TERM:

The initial contract term commenced March 11, 2020 and will continue until October 11, 2023 with the option for state renewal or extension.

RECOMMENDATION:

It is the recommendation of Susan Hann, Assistant Superintendent of Facilities Services and James Ross, Director of Plant Operations & Maintenance to increase the value of the state contract utilization with the above noted vendors to a variable amount.

AUTHORITY FOR ACTION:

Florida Administrative Code 6A-1.012 (5)
