As allowed per Florida Administrative Code 6A-1.012(5) and required by Section 1001.42(10)(j), F.S., the district school board shall receive and consider the prices available to it under rules of the Department of Management Services, Division of Purchasing. District school boards may use prices established by the Division of Purchasing through the state purchasing agreement price schedule. **CONTRACT TERM:**
