**DISCUSSION:**

State Board of Education Rule 6A-1.012 (5), the district school board shall receive and give consideration to the prices available to it under rules of the Department of Management Services, Division of Purchasing. District school boards may use prices established by the Division of Purchasing through its state purchasing agreement price schedule. If district school board policy provides for purchasing under this program of state purchasing agreements the conditions for use shall be those imposed on state agencies.

Auditorium seating renewal is included in the year 1 of the 2020 sales surtax plan for Rockledge High School and Palm Bay Magnet High School.

The six year sales surtax program also includes renewal of other classroom furniture and cabinetry.

The standard state contract agenda template has been used, which does not require legal review.

**CONTRACT TERM:**

The initial contract term shall commence April 14, 2021 and continue until April 13, 2022.
