My name is Christina Matthews and I reside in the Grand Haven HOA (on Fenrose Circle) community directly south of the Pineda Causeway and east of I-95. We are zoned for Longleaf Elementary School (A rated school), Johnson Middle School (C rated school), and Viera High School (A rated school). One of my children attends Longleaf Elementary and another of my children attends preschool in the Suntree area. We play Viera little league baseball, attend church in Viera, shop and eat at the Avenues, and participate in many of the activities in the Viera/Suntree community. All of the presentations focus on the boundaries for the new middle school, but I do not see anything regarding rezoning for DeLaura Middle School. Specifically, I would like to know if it is being considered to redistrict Ocean Breeze Elementary (OBE) so that all of the students are zoned to attend DeLaura instead of being split between Hoover and DeLaura. OBE is the only elementary school beachside (maybe even great area) that is split & zoned for two middle schools. It would seem to make sense to rezone all of OBE students to DeLaura since all the students zoned for OBE are also zoned for Satellite High while most students who are zoned for Hoover are zoned for Melbourne High. Can you please tell me if this is being considered as part of the middle school boundary zoning? If it is not being discussed now, when will it be discussed?

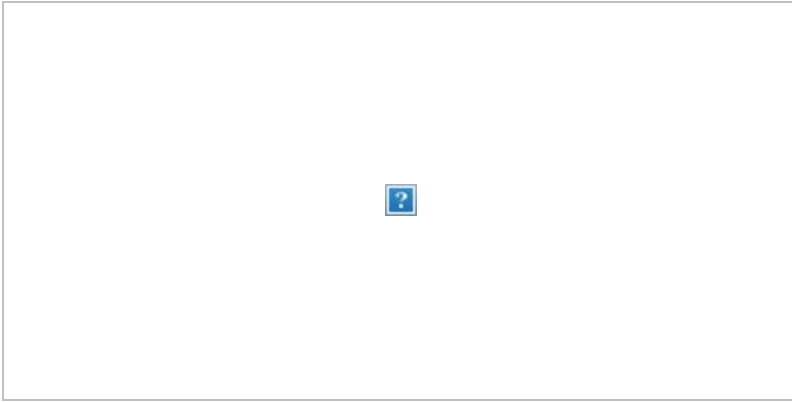

Chelsea Park is a neighborhood off Barnes in Rockledge which has always been apart of the Viera Community. Chelsea Park has been zoned for Manatee Elementary since the school opened. We have been looking forward to a new middle school in this area for a very long time.

Over the past several years we have seen many children leave public school and transfer to the charter school options in Viera. Part of that is for education, but a large part of that is because we want to keep our children with their friends and families whom they built relationships with over time within the Viera community. I personally know about 5 children on our street who attend Viera Charter School, we have been considering it as well to keep our children with familiar faces at school, but highly prefer Brevard Public Schools over the charter system.

Chelsea Park is one of the only neighborhoods that is zoned for Manatee but not zoned for the new middle school. This means our children will grow relationships for 7 years and not have the opportunity to go to middle school with those friends. Middle school can be a trying period for children and being with familiar faces and family will make all the difference for the children.

- Chelsea Park is a very small number of children to be added to the zoning but will provide significant benefit for our children and community.
- I also believe that it will gain back families that have left for the charter schools back into our school system.

I know there is a great deal of work and consideration to be done regarding this new middle school. I am asking that you strongly consider adding Chelsea Park to the zoning for the new middle school. I very much appreciate of everyone's time, thank you.

To the Brevard County school board,

My family has been living in the Auburn Lakes neighborhood in Rockledge (current zone 3) for the past eight years.

We were very excited that plans for a new middle school are finally underway as the promise for a new middle school was a major selling point when we initially bought the house. We know this is true for many of our neighbors, even ones who have lived here for 20 years.

We are thankful for the location of the new middle school; right next to the high school for which we are zoned and only 4.5 miles from our house. Needless to say, it was disappointing to learn we are not promised to be within the school zone of this new middle school.

We would like you to strongly consider including zone 3 in the plans for Viera Middle School.

This school is being built for the growing township of Viera. The neighborhoods in zone 3 are a part of the DRI of Viera - we live in Viera East. It should be understood that our children will be zoned for Viera Middle School.

This is to your advantage as well as you consider bus routes. It is my understanding that school busses will not be allowed to cross the train tracks once the high-speed bullet train is using the tracks. Crossing the train tracks to get to US-1 is currently the fastest way to get to our zoned middle school (McNair). Using city roads would mean driving our neighborhood's students past another middle school to their zoned school. In contrast, we can easily be incorporated with the bus route for other Viera East neighborhoods who are currently zoned for the new school.

I appreciate the county's urgency to include new neighborhoods in this school district to increase the value of these homes that are yet to be sold. However, many of us have stretched our budgets and chosen to live in Viera East for many years because we expected a new middle school to be built by the time our children would be old enough to attend.

We have two daughters. Our oldest will be going to 7th grade in the fall of 2024. She has special needs and has been receiving excellent ESE care at Ralph Williams elementary school. I understand my daughter's needs and believe they would be best met at a (new) school with excellent resources.

To be honest, we do not feel comfortable with our current middle school zone and would not

consider it an option as we select a middle school for our kids. If Viera Middle School is not offered to our kids, we would begin researching private or charter schools in the area.

Our strong preference would be for our kids to receive their education through Brevard Public schools. However, this decision is dependent on Viera East being zoned for Viera Middle School.

We have faithfully contributed to this community over the last eight years of living here and appreciate your consideration to include zone 3 in the school zone for the new middle school.

My sons Max and Evan are in 5th and 2nd grades at Ralph Williams Elementary. Max will be starting middle school in the 2024-2025 school year. We are currently zoned for McNair Magnet Middle School and Viera High School. I believe we should be zoned for the new middle school being built next to Viera High School for the following reasons:

First, when we purchased our home in 2013, we were told by our realtor that a new middle school would be built in the near future, and that we would be zoned for it. Everyone I talk to that lives in our area mentions that we were promised this middle school. To find out that we were excluded from the initial attendance boundary of the new middle school is unacceptable.

Second, we are the only area within the Viera Master Plan not zoned for the new school in Viera. Since moving to the area, we have personally paid \$6,518.29 toward the Viera East CDD. We also pay the annual Viera East Association dues. Some neighborhoods (such as Capron Ridge), which are included in the initial attendance boundary, do not pay this "Viera tax". How is this fair at all?

Third, being zoned for McNair Magnet Middle School and then Viera High School is totally unfair to my children. Most students attending McNair go to Cocoa High or Rockledge High. We owe it to our children to attempt to maintain consistency within their friend groups and peer community whenever possible. Starting high school can be a stressful time in an adolescent's life. Knowing they will have the same friends and familiar faces with them will have a profound impact on easing this critical transition and making it a positive one.

Lastly, Viera Middle School is closer to our house than McNair Magnet Middle School. My sons will use the bus to travel to and from school. Requiring them to spend 30+ minutes out of their day to go to and from a school that is almost two cities away from our home makes no sense, and is an entirely avoidable waste of time.

If we are not zoned for the new Viera Middle School, my family will have to look for other options for middle school, including transferring to Viera Charter School and leaving Brevard Public Schools. I do not want to do this, as I believe in BPS, but I have to do what is best for my children if we are not re-zoned.

Thank you for taking the time to read my email. I hope you consider my concerns, as well as the concerns of my neighbors in Viera East, when you make your recommendation for the final attendance boundary line for the new school.

Dear School Board Members,

I'm requesting that the Viera East communities be included in the base area to attend the new Viera Middle School. Our communities in Viera East (defined as Areas 2 & 3 on the proposal map) were the first communities built as part of the original Viera Development of Regional Impact (Viera DRI). From the very beginning, our community was built with a promise of a future middle school.

For over two decades, our impact fees have been used to build new schools to the north and south, with only a recent elementary school built in Viera. Now that a new middle school is finally coming to Viera, we were shocked to see that the first proposal does not include Viera East! Instead, the base area includes portions of Viera that haven't even been developed yet and a portion of Suntree (defined as Area 1).

It is not right to reserve room in the new school for future residents of Viera West who will move into homes that haven't even been built yet, over students who reside in Viera East today and have been elementary students in Viera elementary schools. If the boundary line is going to be primarily Viera, it needs to include both Viera East and Viera West. Viera East students in Areas 2 & 3 should be prioritized to attend the new middle schools before Suntree students in Area 1.

Viera is unfortunately divided by I-95, creating Viera East and Viera West. This division shouldn't cause any issues, but by sending children in Viera East and Viera West to separate middle schools, the School Board would only be further dividing our community.

While waiting for the District to provide a middle school in Viera, there have been two new charter schools built, both with middle schools. Many of our neighbors have abandoned the district in favor of those schools, primarily for the

middle school option. Now, there are two more charter schools coming to Viera and the district is at risk of losing additional students from Viera East to attend a middle school near their home in Viera.

Please include Viera East, Areas 2 & 3, in the base area for the new Viera Middle School.

Good evening,

I would like to take a moment to express my opinion regarding the recent proposal drafted to align the new middle school boundaries to the various districts within Brevard County. We own a home in area three which currently makes up only 10% of the total existing BPS 5th and 6th grade students in the area (excluding West Shore and Edgewood). Our daughters are entering 1st and 3rd grade in the fall of 2023 which leaves us in a position to risk a lottery selection to go to our local Viera school, choose a charter school, or pay for private education.

My family relocated to Florida 15 years ago to establish a new home for our entire extended family. We searched for a community where we could raise our family in a safe and friendly community with great schools and endless possibilities. One of the topics we often revisited in that decision was the uncertainty of the middle school being a reality while our children were young enough to take advantage of the new facility. In that time, we rented a home and visited other areas including Viera West, Palm Bay, Vero, Stuart, and even more recently discussed the newer communities coming to West Melbourne. Since then, our families have also purchased homes in the area to be close to their grandchildren and nieces, which was based mostly on our family's final decision.

In looking at the data provided, it is assumed that in 2027 (Y4) and 2029 (Y6) each student that attends Viera Middle School from my area (area 3) in years 1-10 represents .0055% of the total school capacity only second to area 2 which each student in years 1-10 represents .0033% of the total school capacity.

In addition to area 3 posing such a minimal strain on the new capacity, I wanted to also mention the following:

1. **Continuity:** My children have been in childcare, VPK, summer camp, and elementary school with their classmates and in the Viera community. This includes Viera Children's Academy and Amazing Explorers. We were accepted to Viera Elementary and decided to stick with Ralph Williams (our neighborhood school) and that has proven to be a wonderful decision. We regularly visit the school and meet other families to play Bingo among other activities. We then meet our new Crane friends outside of school hours. Community and continuity are important and if area three is zoned out, we may have to consider a Charter School for that continuity.
2. **It was sold as part of Viera:** Scripted or not, this was a selling point for any realtor I have spoken with. All the information that was available supported that claim. The values of the homes put us in a tight spot initially, but we were working for our children's future. Had we had this information back when we found Viera, we may have made a different decision which could have left us in the same schools, in a close by neighborhood, paying for a more reasonably valued home for our income at that time.

3. **There is value in shiny and new:** As a representative of a large and progressive tech company, I value the ability to provide my children with the latest technology and how to leverage in a positive way and to learn and grow with the times. While the older schools in Brevard have great technology and resources, we are talking about the difference between hung TVs with internet connection and AI driven smartboards linked to additional resources beyond the traditional brick and mortar.
4. **Ratings: Per [Public School Review.com](https://www.PublicSchoolReview.com)** Ronald Mcnair Magnet Middle School is ranked 15/32 compared to Kennedy ranked 12th Delaura 7th. If history is any indicator, we could expect the new middle school to rank in the top 5. Viera Elementary is rated 3rd 72 schools.
5. **Home Value, this affects more than just the students and their families:** Area 3 has a large population of empty nesters and retirees who were also sold on the value added to our homes when zoned for the Middle school. Per [PubicSchoolReview.com](https://www.PublicSchoolReview.com): A recent study by the Brookings Institution found that housing costs tend to be higher in areas where high-scoring schools are located. The study, which looked at the 100 largest metro areas in the country, found an average difference of \$205,000 in home prices between houses near high-performing and low-performing schools. Homes around high-performing schools also tended to be larger, with 1.5 more rooms than homes near low-performing institutions. In addition, the number of rentals in areas near high-performing schools is around 30 percent lower.
6. **Coming Soon- 2 New Charter Schools:** This will draw additional students from the projections provided decreasing the strain on the capacity
7. **Transit:** Currently we are 1 mile from our school. If we are not placed within the new boundaries, we will have to put our children on a bus to go 7 miles north. A direct route via car is 15 minutes. I would estimate my children being on a bus for at least 45 minutes or more each way and in the complete opposite direction of our employers and activities. Additionally, the new high-speed train will cause changes to the bus routes requiring them to use Fiske in place of Route 1 adding to the commute time.
8. **Timing:** The homes that are guaranteed in the main area have not even been built yet. Our home was built in 2005 so I would like to think that we would have 18 years of Viera pride and a long history as contributing members to the Viera community and a voice in this decision.

I want to thank you for all the time spent on making this decision. We love Brevard and so far, our experience (which was COVID Kindergarten) was still a wonderful experience. We hope to continue our education with our existing community and appreciate your considerations.

Dear Brevard School Board Members and Acting Superintendent Hann,

I am writing regarding the question of zoning for the new middle school that will be in Viera. I am a resident of Suntree. Both of my children currently attend Suntree Elementary School. My 6th grader will be attending DeLaura Middle School next year for 7th grade.

I wanted to voice my opinion that **I do NOT think that Suntree should be zoned for the new middle school**. I attended the meeting at Suntree Elementary where Ms. Hann and Mr. Susin addressed the issue. I was concerned that including Suntree within the new middle school boundaries would cause the new school to open at a 92% capacity, especially when Ms. Hann explained that the goal is to open a new school at closer to 70% capacity. I was further concerned when the projected attendance for the new middle school in several years was close to 130%. That is outrageous and seems irresponsible.

Mr. Susin promised that no rezoning of Suntree would occur in the future regarding middle schools. This seems like something that can not possibly be promised. If the capacity could potentially reach 130%, I believe Suntree will very likely be rezoned again in the future, likely right back to DeLaura. It seems foolish to make these sorts of promises, and I think the residents of Suntree will be addressing this again in just a few years.

Additionally, when the question was raised about where the teachers would come from for this new middle school, Mr. Susin said that a lot would probably come from other Brevard schools. This is concerning because it would be pulling the best and brightest teachers into just one school, diminishing the teacher quality in existing schools. This is like putting all our resources in one basket, which also seems irresponsible. I think opening this new school with a lower student population would help mitigate the number of teachers flooding into the new positions and leaving open positions throughout the county.

I urge you to vote against including Suntree in the boundaries for the new middle school.

Thank you once again for completing our on-line survey and providing comments on the attendance boundary for the New Middle School in Viera. We are including all comments and survey results with the School Board agenda package.

Based on School Board guidance at the March 28, 2023 work session and a high level of community engagement, staff is recommending that the new middle school attendance boundary **include the Base area PLUS Areas 1, 2, and 3**. Area 1 includes the Suntree Elementary area, while Areas 2 and 3 include Viera East. Staff recommendations for the proposed attendance boundary for the new middle school were submitted to the Board as an information agenda item at the April 11, 2023 School Board meeting. This was to inform the Board and no action was taken. During the April 25, 2023 School Board meeting, the School Board voted to approve advertising the Public Hearing for May 30, 2023.

The final step is for the School Board to hold the Public Hearing during the May 30, 2023 School Board meeting at 5:30 pm where the Board will vote on FINAL approval. The Public Hearing will be held at the Educational Services Facility (School Board Office) located at 2700 Judge Fran Jamieson Way, Viera, FL 32940. This will set the attendance boundary for the new middle school, which is scheduled to open August 2024!!

Chelsea Park is a neighborhood off Barnes in Rockledge which has always been a part of the Viera Community. Chelsea Park has been zoned for Manatee Elementary since the school opened. We have been looking forward to a new middle school in this area for a very long time.

Over the past several years we have seen many children leave public school and transfer to the charter school options in Viera. Part of that is for education, but a large part of that is because we want to keep our children with their friends and families whom they built relationships with over time within the Viera community. I personally know about 5 children on our street who attend Viera Charter School, we have been considering it as well to keep our children with familiar faces at school, but highly prefer Brevard Public Schools over the charter system.

Chelsea Park is one of the only neighborhoods that is zoned for Manatee but not zoned for the new middle school. This means our children will grow relationships for 7 years and not have the opportunity to go to middle school with those friends. Middle school can be a trying period for children and being with familiar faces and family will make all the difference for the children.

- Chelsea Park is a very small number of children to be added to the zoning but will provide significant benefit for our children and community.
- I also believe that it will gain back families that have left for the charter schools back into our school system.

I know there is a great deal of work and consideration to be done regarding this new middle school. I am asking that you strongly consider adding Chelsea Park to the zoning for the new middle school. I very much appreciate of everyone's time, thank you.
